**Second Amended ♦**: Cancels the 341s meetings scheduled for January 23, 2017. Changes Judge Jernigan's July 13<sup>th</sup> date to July 6<sup>th</sup>, 2017.

**Third Amended =**Deletes the NOI days off the calendar. They are now heard on regular Docket Days.

**Fourth Amended •**=Changes Judge Jernigan's August court date from the 10<sup>th</sup> to the 3<sup>rd</sup>

**Fifth Amended »**=Changes Judge Houser's afternoon hearings to Sept 28<sup>th</sup>, pre-hearings will remain on the 21<sup>st</sup>.

**Sixth Amended +**=Changes the hearing dates for Judge Houser in July and August. Also deletes a 341 date for December 28, 2017.

**Seventh Amended ○**=Changes Judge Jernigan's hearings in September to the 21<sup>st</sup> but **pre-hearings** remain on the 14<sup>th</sup>.
