Fourth Amended •=Changes Judge Jernigan's August court date from the 10th to the 3rd

Fifth Amended »=Changes Judge Houser's afternoon hearings to Sept 28th, pre-hearings will remain on the 21st.

Sixth Amended +=Changes the hearing dates for Judge Houser in July and August. Also deletes a 341 date for December 28, 2017.

Seventh Amended ○=Changes Judge Jernigan's hearings in September to the 21st but **pre-hearings** remain on the 14th.
